The past year has shown us a few things; **the complexity and severity of challenges that today's parents face is worsening, the need for innovative, expert solutions to address those challenges is increasing, and most importantly, with your ongoing support Beech Acres Parenting Center is uniquely positioned to serve parents, families, and children in the community for years to come.**

Flexibility and adaptability were pivotal – and our *Parent ConnexT™* team continued **providing virtual parent coaching that improved parents' relationships with their children after just 3 sessions.**

Parents seeking continuity and stability from last year's turbulence found it thanks to our *Beyond the Classroom™* team. **Our Team Leads and Therapists continued to provide a safe space for parents and students to seek help,** even with the disruption to their learning environment caused by the ongoing COVID-19 pandemic.

Despite the many challenges we faced in the last 12 months, **we were able to grow, serving over 31,000 parents, caregivers, teachers, and children.** This growth was fueled by our child welfare team who increased the number of licensed foster homes in the Greater Cincinnati area and expanded into Montgomery County, making it possible for Dayton-area families to receive the support and training to successfully

foster a child in need. In addition, our popular Social and Emotional Learning program, The Character Effect™, has just begun a national expansion to serve even more teachers, students, and parents.

Growth within Beech Acres continued as well, as we have made diversity, equity, and inclusion a top priority. Our aspirations are high as we work on our goal to “develop and execute an anti-racism strategy for those we serve, the systems affecting them, and within Beech Acres itself.” This is an essential part of the legacy passed to Laura Mitchell as a new era begins for Beech Acres Parenting Center under her expert leadership and the continued partnership of supporters like you.

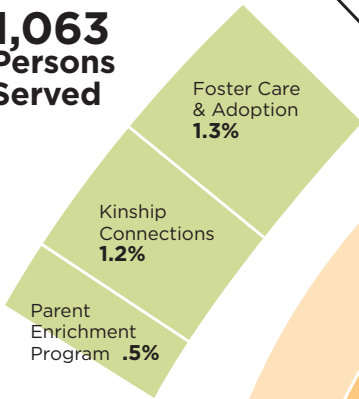

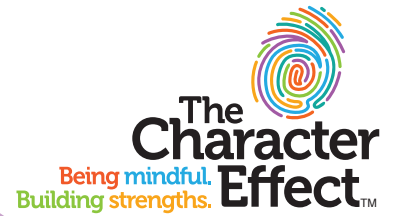
CHILD WELFARE CONTINUUM OF CARE

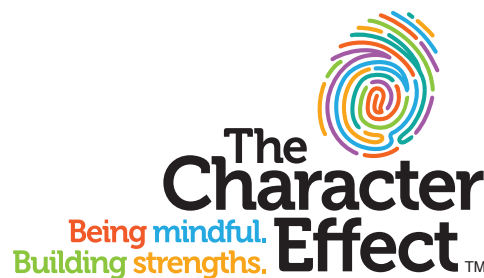

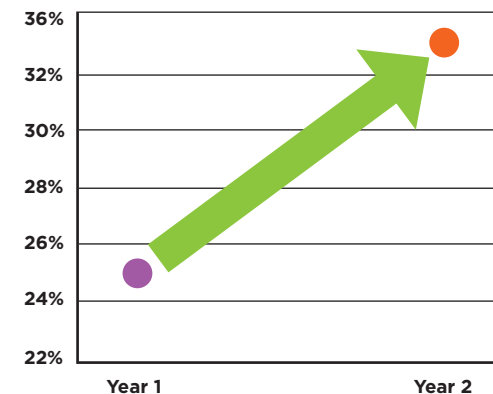

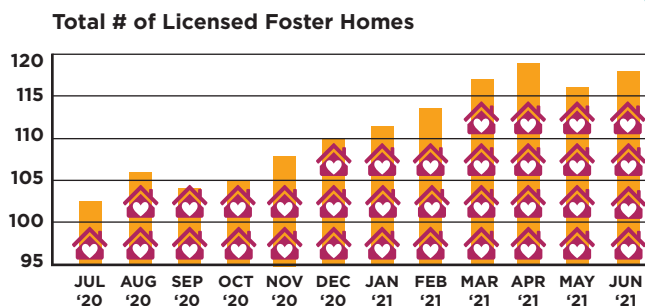

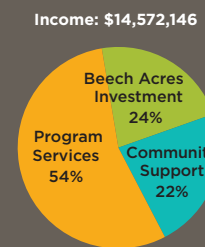
